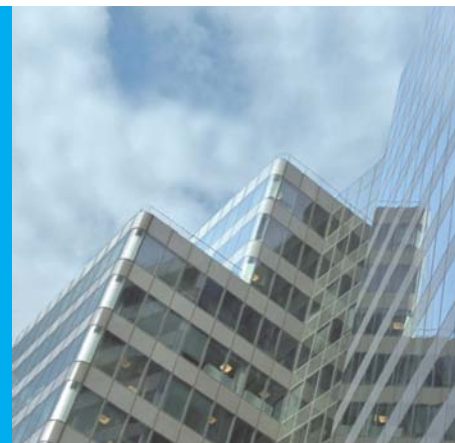

The FSA has kindly agreed to give members of the Japan Society, the Japanese Chamber of Commerce and Industry in the United Kingdom and the British Japanese Law Association, a briefing on the recent Review by Lord Turner, a paper which is likely to have far-reaching effects for us all.

In October 2008, The Chancellor asked Lord Turner, The Chairman of The FSA, to make recommendations on the changes in regulation and supervisory approach needed to create a more robust banking system for the future. The Turner Review and the associated discussion paper respond to that remit, focusing on the fundamentals and long-term questions. It makes a number of recommendations and sets out open issues. Some of these recommendations have already been, or are in the process of being, implemented. Many of the most important steps, however, will depend on international agreement. Although there is broad consensus on many of the underlying principles, there are different national views on implementation and the Review recognises that final agreements may reflect these principles in different implementation options.

Key points will include; the need for a new countercyclical capital regime, the scope of regulation, the need for an International approach and changes to supervisory approaches.

David Cook joined the FSA's International Policy and Strategy Coordination team in 2008, where his first substantive role has been project coordinator for the development and publishing of the Turner Review. Before joining the FSA, Mr Cook held a number of Policy Advisor posts in the Department for International Development (2006-08) and HM Treasury (2002-06), working on policy relating to the European Investment Bank, international debt and child poverty.
